

Park Rules

NOTICE: failure to follow any of the following rules of Paintball ParaDyes could result in the removal of your wristband with **NO REFUND**. Paintball ParaDyes reserves the right to amend the park rules at any time.

- 1). **FIELD PAINT ONLY!!!** All paintballs must be purchased from Paintball ParaDyes on the day you are playing.
- 2). A Paintball ParaDyes referee has the **FINAL** word on all calls. Respect their decisions.
- 3). Goggles **MUST** be worn the entire time you are on the field or in the chronograph area.
- 4). **Barrel sleeves are mandatory!!** And must be in use when not in a field playing.
- 5). Please follow "courteous playing habits"
 - No close shooting or bunkering
 - No blind shooting
 - Do Not** shoot anyone more than 3 times
- 6). Long sleeve shirts and long pants are recommended, no required.
- 7). Profanity and inappropriate conduct will **NOT** be tolerated. Paintball ParaDyes is a public recreation facility with a family oriented environment.
- 8). Any defacing of property in any way will **NOT BE TOLERATED. If you are caught defacing the property, you will be removed from the premises immediately.**
- 9). Any switching of wristbands and equipment is prohibited and will terminate your admission immediately.
- 10). **INTENTIONALLY SHOOTING AT REFEREES WILL NOT BE TOLERATED. PLAYER WILL BE ESCORTED FROM THE PARK IMMEDIATELY!!!!!!**

IN CONSIDERATION of being permitted to participate in any way in the sport and activities of paintball on the premises of Paintball ParaDyes, I acknowledge, appreciate and agree that:

1). I understand and agree that this Release of Liability Agreement covers each and every paintball activity and event, in which I participate hereafter, and:

2). The risk of injury from the activity and weaponry involved in paintball AND the operations of the air fill stations AND the use of rental equipment is significant, including the potential for permanent disability and death, and while particular protective equipment and personal discipline will minimize this risk, the risk of serious injury does exist, and:

3). I knowingly and freely assume all such risks, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE of those persons released from liability above, and assume full responsibility for my participation, and:

4). I understand that the activities of paintball are physically and mentally intense. I understand the rules of conduct for play and will comply with all rules and regulations AND understand that failure to follow the rules could result in expulsion from the facility, without a refund. If I observe any unusual or unnecessary hazard during my participation, I will bring such to the attention of the nearest employee as soon as practical, and:

5). I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS FROM LIABILITY, PAINTBALL PARADYES, (the owners and lessees of premises used to conduct the paintball activities) their officers, officials, agents and /or employees, WHETHER CAUSED BY THE NEGLIGENCE OR THE RELEASES OR OTHERWISE.

6). I understand the following limitations, the max velocity has to be 300 fps or less, the markers are not allowed to ramp up to more than 15 bps, and a 20 foot surrender rule must be enforced (if a target is within 20 feet, they must be allowed to surrender. If the target declines, the player is allowed to fire at will).
